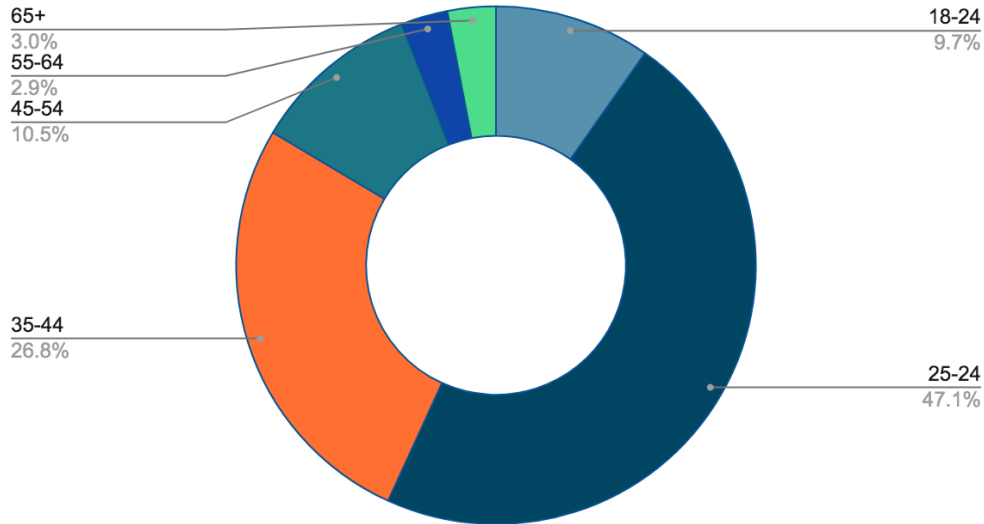

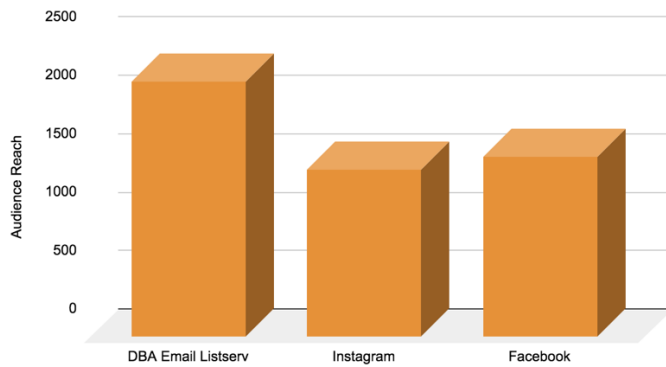


Instagram Audience Age Demographics



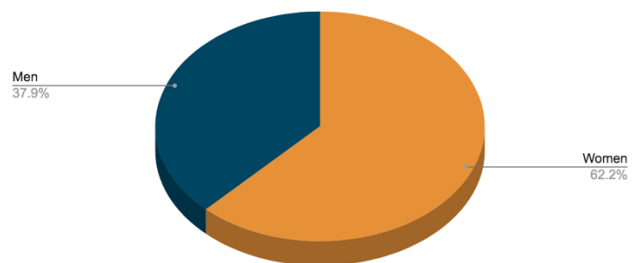



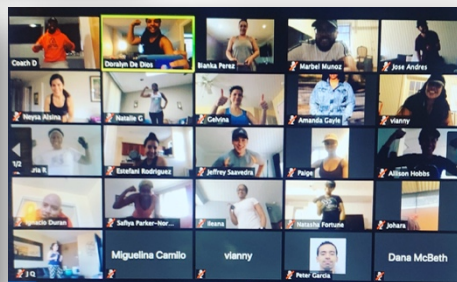
